

A NOTE TO PARENTS/GUARDIANS

The daily use of this agenda will assist your child in becoming a better organized and effective learner. It also serves as a guide of what your child can expect from the school and highlights his or her responsibilities.

EMILY CARR'S CODE OF BEHAVIOUR

All members of our school community are committed to ensuring a safe, stimulating, and positive learning environment where all individuals can question, learn, experience, and grow to their full potential. Creating this environment requires the cooperation, full attention, and best efforts of students, teachers, and parents/guardians working together.

All members of our school community are entitled to be treated fairly and with respect. In return, they have a responsibility to behave towards others in the same way. All students must be aware of and follow all school rules during all school-sanctioned activities and field trips. Together we create an environment where students, staff and parents/guardians feel valued, safe, and respected.

WE EXPECT OUR STUDENTS TO ...

Be Respectful

- Be honest and truthful
- Respect other people's feelings and differences
- Respect other people's belongings and public property
- Respect themselves
- During assemblies and public events, show respect for the performers and audience

Be Mannerly

- Use polite language
- Be punctual
- Practise cleanliness/personal hygiene

Be Responsible

- Complete assigned work with care
- Respect due dates for assignments and projects
- Properly prepare for tests
- Ensure that if absent, missed assignments are completed
- Follow classroom rules and routines
- Deliver notes and letters to parents/guardians and teachers
- Be organized and be prepared for class

Be Safe

- Follow all protocols
- Show self-control at all times
- Follow yard rules
- Stay on school property
- Report any injuries, problems, or dangerous behaviour to yard duty teachers
- Stay within the designated areas during recesses



BUS SAFETY

- Respect bus drivers and other students
- Remain seated at all times
- Talk quietly
- Keep hands, head and other objects in the bus
- Wait for the bus to stop before moving from your seat
- Do not eat or drink on the bus
- Ensure that balls, skates, etc. are carried in a bag while riding on the bus

*Please note that hockey sticks or large bulky projects are not permitted on the bus.

For their own protection, students must observe these safety rules while on school buses. In cases where safety rules are not followed, the driver will first seek the cooperation of the student. If there are continued difficulties, the driver will report the student to the Principal. For repeated problems, there may be a withdrawal of transportation services for a specific period of time.

Please note that students must always ride their assigned bus. Notes to take a different bus will not be accepted. Permanent route or stop changes must be arranged through the office and take 3-5 business days to implement.

Use your "WITS":

- Walk Away
- Ignore
- Talk it out
- Seek help

IF YOU FORGET...

Someone from the school staff:

- Will encourage you to solve the problem peacefully
- Will give you a warning
- Will inform your teacher
- May ask you to go to the office
- May have you serve a detention

In the office, the Principal:

- Will ask you to explain why you have been sent to the office
- Will help you solve the problem in order to avoid it happening again
- Will decide on appropriate consequences (loss of privileges, time-out, detentions, in-school sanction and/or suspension)
- May send a letter and/or call your parents/guardians
- May inform police of serious or repeated offences
- May seek restitution (repair or replace)

PROGRESSIVE DISCIPLINE

Progressive discipline is a whole-school approach that utilizes a continuum of interventions, supports and consequences to address inappropriate student behaviour and to build upon strategies that promote positive behaviours. When inappropriate behaviour occurs, disciplinary measures are applied within a framework that shifts the focus from one that is solely punitive to one that is both corrective and supportive.

At Emily Carr, we utilize a range of interventions, supports, and consequences that include learning opportunities for reinforcing positive behaviour while helping our students make good choices. They include:

- Peer/teacher mediation
- Discussions with teachers
- Reprimand from a teacher
- Parental/guardian involvement
- Detention
- Complete appropriate assignments
- Withdrawal of privileges
- In-school sanction
- Restitution where appropriate
- Imposition of behavioural or performance contract
- Intervention to Special Services
- Involvement/referral to School Resource Officer
- Suspension from school
- Expulsion from school

REASONS FOR CONSIDERATION OF SUSPENSION

The reasons for suspension under the Education Act and/or Board policy will appear in the suspension letter.

Reasons for Suspension

- Uttering a threat to inflict serious bodily harm on another person
- Possessing alcohol, cannabis or illegal drugs
- Being under the influence of alcohol
- Being under the influence of cannabis, unless the pupil is a documented medical cannabis user
- Swearing at a teacher or another person in a position of authority
- Committing an act of vandalism that causes extensive damage to Board property or to property on Board premises
- Bullying
- Persistent opposition of authority
- Habitual neglect of duty as a student
- Willful destruction or theft of school property or property located on school premises
- Profane or improper language
- Conduct injurious to the physical or mental well-being of others in the school
- Inappropriate use of information technology, as defined in Board policies and procedures
- Smoking or vaping on school/district premises
- Possessing, selling or providing prescription drugs and alcohol or distributing any tobacco products
- Selling, distributing or providing any illegal drugs, alcohol, cannabis, and/or any vaping or tobacco products

- Being under the influence of alcohol, cannabis, or illegal drugs
- Any act considered to be contrary to the district or school code of conduct or Board policies

INSTRUCTIONAL DAY EXPECTATIONS

Entry/Exit:

- Enter and exit the building through your designated door
- Walk quietly in a single file along the right side of the hall
- Gain permission from a staff member to be in the school at recess, before or after school
- Seek staff permission to use the washroom, fill up your water bottle or access the office

At recess time:

- Obtain permission from staff on duty and enter the school through the front door
- Technology is not permitted

During nutritional breaks:

- Remain seated and facing forward
- Talk quietly
- Keep eating area clean
- Use good manners
- Take all garbage home with you
- Do not share or exchange your food with others
- Staff permission is required to leave the instructional area

During indoor recess:

- Remain in your designated area
- Engage in a quiet activity and talk quietly
- Technology is not permitted
- Staff permission is required to leave the instructional area

Rough play, play fighting and bullying:

Are not permitted

Throwing ice, snow and snowballs:

Are not permitted

Valuables:

 Leave all valuables at home; we are not responsible for lost or stolen items

Food and Drink:

- Food and drinks are not to be consumed outdoors
- Gum chewing is prohibited inside the school and on the school yard

Bicycles:

- Bicycles must be walked on school property
- Lock bicycles in the appropriate racks
- Cyclists are required by law to wear a helmet
- We are not responsible for stolen bicycles

In-line skates, heelies, scooters and skateboards:

Are not to be used on school property

DRESS CODE

Following the District's Dress Code for students, student clothing must:

- cover the groin, buttocks and nipples with material that is not see-through or transparent
- include more than underwear as the only layer of clothing
- include footwear with consideration for health and safety
- ensure that the student's face is not fully obscured
- not include wording or graphics that reasonably could be construed as promoting or symbolizing hate or discrimination, drugs, alcohol, tobacco, Cannabis, illegal activity, profanity, nudity, pornography or that incites violence or harassment; or threatens health and safety.

LIFE THREATENING MEDICAL CONDITIONS

If your child has a life threatening medical condition, such as Anaphylaxis, Asthma, Diabetes, Epilepsy, etc. a <u>Plan of Care</u> online form needs to be completed. This form will be sent to the parent/guardian by email. The Plan of Care form must be renewed each school year.

If you feel you need to complete such a form and it has not been sent to you, please contact the office.

Medication

Board regulations require that all student medication being administered at the school be reported to the office. Should a student require medication during school hours, a permission form must be completed, this form will be sent to the parent/guardian by email. No medication, including over the counter medication such as Tylenol, is to be dispensed to a student without the appropriate documentation. Medication forms must be renewed each school year.

Student Illness

Pending district direction, all students may be required to complete the Covid-19 self-assessment prior to coming to school and to follow the instructions provided in the assessment.

When a student becomes ill at school, the office will contact parents/guardians immediately. If they are unavailable, we will call the person identified as the emergency contact person. Students are required to contact parents/guardians from the office. For safety, texting is not permitted. Once again, we stress the importance of informing us of changes in home, cell or work telephone numbers.

If your child presents with Covid-19-like symptoms while at school, your child will wait for pick-up in our isolation room. Your child may be marked absent for the next few days based on OPH's advice at the time.

SCHOOL PROCEDURES

Absences

If your child will be absent or late, parents/guardians are asked to call the school (613-824-5455 ext. 1). The answering machine is on 24/7. When a phone call has not been received, parents/guardians will be contacted by the office staff as part of the Safe Arrival Program.

Arriving Late or Leaving School During the Day Students arriving after the entry bell are to identify themselves to office staff via the front door intercom and state the reason for their late arrival. Students then proceed directly to their class. Late arrivals will be closely monitored, and chronic late arrivals will be addressed.

Students who need to leave the school early are to identify themselves to office staff and then be picked up by their parents/guardians. Parents/guardians are asked to send a note or email to the teacher and office indicating the time of pick-up. Please ensure that your child is aware of scheduled appointments so that they can be ready to leave at the required time. It is very disruptive to other students when a student needs to be called out of class.

Attendance

Good attendance is the basis for academic achievement and success at school. The Ontario government requires that all students attend classes punctually and regularly.

Care of School Property

All students are responsible for the general care of the school building, furniture, technology, equipment and materials. Students are responsible for the cost of damage to school property and materials. Textbooks, library books and technology are the property of the school and are to be afforded proper care. Students who deface, destroy or lose books and technology will be required to pay for their replacement.

Digital Citizenship and Safety

At Emily Carr, we believe that technology can be a powerful tool to enhance learning. Parents/guardians and students are asked to review and submit the online Acceptable Use of Technology Agreement. Students will not have access to technology or WIFI until this document is completed. Supporting the safe use of technology and teaching students to make good decisions in their use of technology is our goal.

Dressing for the Weather

Students should be properly dressed for all weather conditions. They go outside for all recesses in the winter unless the wind chill factor is too severe (-25 and below). In the winter, neck warmers are recommended.



Scarves and drawstrings on jackets and sweatshirts can pose a danger as they can become snagged on school bus handrails or doors, on school yard equipment or other mechanical equipment. In the spring, please ensure students have adequate sun protection.

Emergency Closing Procedures

In the event of a school closing, local radio and TV stations are alerted to broadcast information on route cancellations or total transportation shutdowns. OCDSB and OSTA websites, Twitter and Facebook will also include this information.

It may be necessary to close the school during the day. This information will be communicated through School Messenger as well as local media sources. It is essential that students know what to do if there is no adult at home.

When buses are cancelled and the school remains open, transportation to and from the school is the parents/guardians' responsibility. When buses are cancelled in the morning, they are cancelled for the day. Any special food days (pizza, pitas) are cancelled when transportation is cancelled.

Parents/guardians are reminded of the importance of informing the school of any changes in home and work telephone numbers, as well as caregiver or emergency contact changes.

Field Trip Procedures

Parents/guardians will receive an electronic field trip permission form for every activity off school property. Without parent/guardian consent on the appropriate form, the child cannot participate in the activity. In accordance with the procedures set out by the Ottawa-Carleton District School Board, we are unable to accept hand-written notes or telephone calls.

Lockers

Every student will be assigned a locker. Students will be required to use a combination lock on their assigned locker. Students should not share their locker combination with other students. Students will have access to their lockers at recess and nutritional breaks to prepare for their next activity or instructional period.

Lost and Found

Every year, many items are not claimed from the Lost and Found box. Students are urged to label all their possessions and to check the Lost and Found box on a regular basis for their belongings. Unclaimed items are donated to a local charity.

Lunch Time Procedures

Students are expected to eat lunch at school and to remain on school property at lunch time.

At Emily Carr, we want to create an environment where the healthiest choices are the easiest choices for students to make. All food and beverages sold at Emily Carr meet the nutrition standards set out in the School Food and Beverage Policy (PPM 150). While the

Beverage Policy (PPM 150). While the nutrition standards do not apply to food and beverages that are brought from home, we encourage our students to bring healthy lunches and snacks.



As a school community, we are committed to making our school a healthy place to learn. In doing so, we promote healthy choices beyond what is required in the policy. We appreciate your support as we endeavor to "walk the talk" of healthy eating.

At Emily Carr, we have many students who have life threatening allergies to nuts. We expect that students do not bring food containing nuts.

School Yard

Our primary concern on the school yard is for the safety and security of every student. As such:

- Students are not permitted to throw ice, snow, snowballs, rocks, sand or any projectile that has the potential to injure another student
- Students are not permitted to litter or be on neighbouring properties
- Games involving physical contact such as tackle football are not permitted
- Rough play and play fighting are never permitted
- Skateboards, roller blades, scooters, regular hockey sticks, toy guns or any other toys that might be dangerous in a crowded environment are to be left at home

The school does not take responsibility for the replacement of articles that might be damaged or lost while at school. As a result, it is recommended that expensive possessions like earbuds, cell phones, and tablets are not brought to school.

Telephone Calls

School telephone lines are very busy and are to be used by students only in emergencies. Forgotten gym wear, skates, assignments, or field trip permission forms are not considered emergencies. Phone calls of this nature do not encourage students to be responsible. To respect classroom learning time, students will not be called to the telephone to receive personal messages.

Visitors

All visitors must identify themselves at our front door via the camera and intercom. Office staff will "buzz" visitors into the building where they will be greeted in the office and given an identification tag. As ha courtesy, all classroom visits by parents/guardians should be prearranged with the teacher involved.

Yard Supervision

As no supervision is provided before 9:00 am or after 3:45 pm, students should not arrive before 9:00 am and must leave the school grounds promptly at 3:45 pm, unless taking part in a supervised activity.

HOMEWORK GUIDELINES

Homework provides an opportunity for students to complete assignments and practice skills. Encouraging your child to read daily is a wonderful way to enhance learning. A guideline for a suitable amount of homework time is 10 minutes per grade level.

Parents/guardians are encouraged to monitor the time spent on homework and to communicate with the school to keep a healthy balance. We all need to work together to help students plan and organize their time to work towards assignment deadlines and to avoid homework anxiety.

Benefits of Homework:

- Practice and reinforce skills from daily school work
- Complete unfinished work
- Develop lifelong study skills (learn to prioritize)
- Develop responsibility for their work
- Boost self-esteem
- Develop strong work habits
- Develop self-discipline
- Develop independence
- Develop time management skills

Role of Parents/Guardians:

- Establish homework routines
- Guide (help child organize and prioritize)
- Supervise
- Provide a quiet workplace
- Hold child accountable
- Encourage dialogue
- Communicate concerns
- Love, support and encourage

Homework Routine:

Regular Time

If possible homework should be done at the same time each day. This becomes a part of the everyday life.

Everyday

The question should always be, "What are you going to do for homework today?"

Communicate

Do not hesitate to contact the teacher with your questions or concerns.

Time

Watch the time to make sure it is appropriate for the grade level. You may want to use a timer to help your child to be conscious of time and how to use time effectively.

Cooperation: I work with others to make a peaceful community. I am willing to listen to others' ideas and suggestions. I compromise and negotiate to solve problems and differences of opinion.

Cooperation sounds like:

- Pardon me.
- Excuse me.
- May I please...
- Thank you.
- Can I help you?

Empathy: I am compassionate, caring, and kind. I am a true friend. I will walk in your shoes in order to understand you. I am slow to judge and quick to forgive.

Empathy sounds like:

- It happened to me once too.
- I know how you feel.
- I'm so happy for you!
- You look upset.
- I'm sorry for you.
- That must hurt a lot.

Fairness: I make decisions based upon the whole picture. I treat others the way I would like to be treated. I am just.

Fairness sounds like:

- It's your turn!
- You go first!
- Let's share!
- Thank you.
- Do you want to join us?
- She hasn't had her turn yet.

Integrity: I behave ethically and honourably. I am honest, loyal, and trustworthy. I am truthful and courageous. I stand up for what is right even when it is hard. I am a person of my word and people who know me understand that.

Integrity sounds like:

- Thank you for following my instructions.
- I brought in the work you asked me to bring.
- You can depend on me.
- I can count on you.

Optimism: I believe that challenges are opportunities. I choose to see goodness. I have hope for our future.

Optimism sounds like:

- What a beautiful day.
- Thank you for believing in me.
- I'll try harder next time...
- I can do this!
- I'm looking forward to...

Perseverance: I will work hard and I will not give up. I will finish what I begin and I will not give up. I will care enough and I will not give up.

Perseverance sounds like:

- Don't give up!
- Nobody succeeds without trying.
- Try, try again!
- Practise, practise, practise!

Respect: I honour myself and others through my words and actions. I support our diversity of beliefs. I treat our world and everything in it with dignity.

Respect sounds like:

- Pardon me.
- Excuse me.
- May I please...
- Thank you.

Responsibility: I am accountable for the decisions I make. I realize that my decisions impact my community. I honour my commitments.

Responsibility sounds like:

- I can do this!
- I can do it on my own!
- I can do it by myself!
- Here is my completed homework.
